The SPLC even went so far as to list renowned African American neurosurgeon Dr. Ben Carson on its supposed "Extremist Watch List." Further, after including Islamic scholar Maajid Nawaz on its "Field Guide to Anti Muslim Extremists," it was forced to pay Mr. Nawaz a \$3.375 million settlement.

The attacks against Mr. Leandri are the latest examples of this kind of hateful behavior by the SPLC. The hateful and vicious attack on this honest American citizen, simply because he was scheduled to host an ACT for America speaking event at a local church, is reprehensible, and the people of Pennsylvania should be outraged.
